Licenses are valid for the calendar year only, unless otherwise suspended, revoked or extended. Applications for renewal will be provided by the Member Clubs. A FIA Driver's License is not transferable, under penalty of revocation of the license.

Additionally be aware of the Therapeutic Use Exemptions (TUE) process as outlined in Appendix A of the FIA International Sporting Code.
