# **IMPORTANT INFORMATION ABOUT TESTING**

- Testing kits and materials are available on site at the designated locations.
- Do not plan to send more than three (3) people at a time without scheduling in advance with the facility.
- Please notify the facility of the name of the team when you register so your test will be coded correctly.
- Please take a photo ID such as a Driver's License, Passport, or 2023 Hard Card.

### PRE-LICENSING CATEGORIES - SECTION III. A. OF THE 2024 INDYCAR SUBSTANCE ABUSE POLICY

- 1. INDYCAR SERIES and INDY NXT:
  - a) **Competitors**: Competition, Drivers, Engineering, Operations, and Team Managers
  - b) **Officials**: Medical, Officials (includes Technical Inspection and Observers), Operations (includes Fuel Services and Transportation), Pace Car, Race Control, Technology (Timing and Scoring), and Track Safety

#### **IMPORTANT REMINDERS**

INDYCAR requires that Members subject to the pre-license testing requirement provide a negative/nondilute result prior to participating in an event.

Members subject to the pre-license requirement should plan to test a minimum of **two weeks** prior to the first event they plan to participate, to allow for processing and results, and to avoid rush charges. Those that may test positive for a prohibited substance should contact the Medical Review Officer (MRO) and allow additional time for review. The MRO can be reached at <u>MRO@AukMed.net</u>
