NO PARENT OR LEGAL GUARDIAN SHOULD SIGN THE APPLICATION WITHOUT A SINCERE BELIEF THAT DOING SO IS IN MINOR'S BEST INTEREST AND WITH THE FOLLOWING UNDERSTANDING: (1) THAT THERE IS SIGNIFICANT RISK OF INJURY, INCLUDING BUT NOT LIMITED TO A RISK OF PARALYSIS OR FATAL INJURY, TO MINOR DUE TO MINOR'S ACCESS AND/OR PARTICIPATION; (2) THAT THE RELEASE, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT WILL PREVENT A CLAIM OR RECOVERY BY MINOR OR ON MINOR'S BEHALF, EVEN IF THE CLAIM INVOLVES THE NEGLIGENCE OF A PERSON OR ENTITY RELEASED; AND (3) THAT EACH PARENT AND/OR LEGAL GUARDIAN WILL BE PERSONALLY RESPONSIBLE FOR ANY COSTS, EXPENSES, AND/OR LIABILITY SHOULD THE RELEASE PORTIONS OF THIS APPLICATION, INCLUDING THE RELEASE, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT AND THE MEDIA RELEASE AND ASSIGNMENT, BE VIOLATED OR MINOR'S RELEASE DETERMINED TO BE INVALID, EVEN IF A RELEASED AND INDEMNIFIED PARTY IS NEGLIGENT.

I certify that I am the parent and/or legal guardian of minor and that all parents and legal guardians of minor have executed this Application. I am executing this Application and entering into the Agreement (as defined below) for and on behalf of myself, minor, and minor's personal representatives, heirs, next of kin, and assigns, including estate of minor.

On behalf of minor, I hereby apply to INDYCAR, LLC ("INDYCAR") for a 2024 Driver's License and for a membership in INDYCAR for the INDY NXT series. For purposes of clarification, if this Application is accepted, minor's Driver's License and membership may permit access to both INDYCAR SERIES and INDY NXT series Events (as defined in the Release, Assumption of Risk, and Indemnity Agreement portion of this Application); provided, however, such license and membership will allow participation as a Driver only in the INDY NXT series. Minor and I understand that if this Application is accepted by INDYCAR, this Application, including the Release, Assumption of Risk, and Indemnity Agreement portion of this Application and the Media Release and Assignment portion of this Application, will become binding agreements between INDYCAR, minor, and me (collectively, the "Agreement"). I acknowledge that minor and I have been provided with or given access to the current INDY NXT Series Rule Book. The current INDY NXT Series Rule Book may be amended by INDYCAR from time to time and the most current version is available at https://epaddock.indycar.com/rules-policies-regulations (collectively, the INDY NXT Series Rule Book as amended from time to time is referred to herein as the "Rules"). The Rules are incorporated herein by reference and also become a part of the Agreement. All capitalized terms not defined herein shall have the meaning set forth in the Rules. Minor and I agree to abide by the Rules, and minor and I understand that minor and I are responsible for Minor Group's awareness of the Rules and conducting themselves in accordance with these Rules. The term "Minor Group" is collectively defined as Minor Guest and each third-party minor represents. Minor and I warrant and represent that we have the right to bind Minor Group as to the rights, privileges and obligations bestowed by minor's License and membership. The term "Minor Guest" shall mean and include any individual whose presence at an Event is at the invitation of minor or me. Minor and I understand that Minor's Driver's License and membership is not transferable and may be suspended or revoked by INDYCAR. INDYCAR may continue to re-evaluate the eligibility of minor at any time after accepting an Application to determine whether minor shall continue to remain eligible to hold a Driver's License. Minor must remain in Good Standing. Minor and I also agree that this Application and the Agreement, including minor's Driver's License and membership, interpretation or application of the Rules, and/or interpretation or application of the Release, Assumption of Risk, and Indemnity Agreement and the Media Release and Assignment, is governed by Indiana law. The exclusive jurisdiction as to any action that involves this Application or the Agreement, including minor's Driver's License and membership, interpretation or application of the Rules, and/or interpretation or application of the Release, Assumption of Risk, and Indemnity Agreement and Media Release and Assignment, shall be a federal or state court sitting in Marion County, Indiana. MINOR AND I WAIVE ANY RIGHT TO A TRIAL BY JURY IN ANY ACTION OR PROCEEDING TO ENFORCE OR DEFEND ANY RIGHTS UNDER THE APPLICATION AGREEMENT AND/OR THE RULES AND AGREE THAT ANY SUCH ACTION OR PROCEEDING WILL BE TRIED BEFORE A COURT AS A BENCH TRIAL AND NOT BEFORE A JURY. Minor and I represent, warrant and covenant to INDYCAR that minor has complied with and at all times will comply with all applicable laws, rules and regulations (whether local, state, federal, or other), including without limitation, all laws related to taxes and fees, immigration, safety/health, transportation, workers' compensation and frequency communications. These responsibilities include without limitation withholding and information reporting obligations required by law pursuant to Indiana Code Section 5-1-17.5. If there is a misrepresentation and/or a breach of these warranties and covenants, minor and I shall indemnify, defend, and hold INDYCAR harmless from any loss or expense (including costs and attorneys' fees) incurred by INDYCAR as a result of any non-compliance including without limitation (i) claims that INDYCAR failed to supervise or achieve compliance and/or (ii) claims of INDYCAR's sole or contributory negligence. With respect to all matters within the scope of minor's and my obligations to defend INDYCAR, minor and I shall provide counsel that is reasonably acceptable to INDYCAR. Minor and I certify that this Application, and Agreement if approved, does not create an employment, agency or joint venture relationship with INDYCAR. The Agreement is intended to be as broad and inclusive as is permitted by law, and it is intended to be fully severable. If any portion of the Agreement is held invalid, it is agreed that the balance the Agreement shall continue in full legal force and effect. That shall include but is not limited to modifying the Agreement to allow the remainder of claims to be waived, released, and/or indemnified against in the event that the inclusion of any particular type of claim is found to be invalid or contrary to public policy.

Minor and I acknowledge and assume all responsibility for any charges, record keeping, premiums and taxes, if any, payable on any funds minor may receive as a result of minor's activities as an INDYCAR Driver and/or Member including, but not limited to, social security taxes, unemployment insurance taxes, workers compensation insurance, income taxes and withholding taxes.

I understand INDYCAR must determine minor's physical and psychological fitness as a condition to issuance of a Driver's License and membership. I understand minor must participate in a medical examination, including any drug testing requested at any time by INDYCAR, and minor agrees to do so. Minor and I understand that minor and I are required to notify the INDYCAR Medical Director if minor or I becomes aware of a change in minor's medical condition including if minor is diagnosed with any medical condition (including pregnancy) by any medical professional. Minor and I further understand that minor is required to immediately notify the INDYCAR Medical Review Officer ("MRO") at any time if minor takes, or is prescribed to take, any drugs or medication (whether or not prescription drugs or medication and regardless of how taken) and that the MRO's approval of such use in connection with an Event is required prior to minor's participation in an Event. In addition, minor and I agree and consent to the Substance Abuse Policy Authorization for Testing and Release ("Authorization") and to minor's participation in all testing for drugs and other substances requested at any time by INDYCAR whether or not the Authorization has been formally executed and to abide by all terms included in the Substance Abuse Policy, which I hereby acknowledge I and minor have reviewed. Minor and I hereby waive any and all claims regarding any testing and/or testing results, including without limitation, claims of invasion of privacy and/or breach of confidentiality of information relating to such testing results, notwithstanding whether such claims arise from strict liability, sole or contributory negligence, breach of contract, or any other legal theory.

For myself and on behalf of minor, I recognize the high risk of injury or death connected with minor's presence and/or participation. I agree and have caused minor to understand and minor agrees that the only way to avoid this risk of presence and/or participation is not to not be present and/or participate. Minor and I understand that once minor's presence and/or participation begins, the risk has been undertaken and can no longer be avoided. I understand and have explained to minor that minor's injury or death, as a result of minor's presence and/or participation, affects not only minor but all of minor's loved ones.

Minor and I have discussed this risk with all those we think appropriate, and explained to them minor's agreement (and my agreement individually and on minor's behalf), to assume these risks and release Participants, INDYCAR, and all others involved in an Event (as defined in the Release, Assumption of Risk, and Indemnity Agreement), including a release from their own negligence (see Release, Covenant and Waiver in the Release, Assumption of Risk, and Indemnity Agreement). Minor and I understand and agree that if minor or minor's representative and/or I fails to deliver this timely written claim to the President of INDYCAR or fails to include the required information, minor and I agree that minor and I will forfeit and waive the right to define the conduct in question as anything worse than conduct that minor and I have specifically released such as negligence.
